MINUTES OF THE MEETING

1. The First Meeting of the Admission Regulatory Committee (ARC) was scheduled under the Chairmanship of Sh. Sanjeev Nandan Sahai, IAS (Retd.) on 04th May, 2023 at 04.30 PM in Dr. B.R. Ambedkar University to deliberate upon the functions of the Committee as provided in the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative fee and Other Measures to Ensure Equity and Excellence) Act, 2007.

3. At the outset of the meeting, the Secretary (Higher Education)/ Member Secretary welcomed all participating members. The meeting was chaired by the Chairman, ARC through online mode.

4. Secretary (Higher Education)/Member Secretary introduced and briefed about the provisions laid down in the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative fee and Other Measures to Ensure Equity and Excellence) Act, 2007 regarding functioning and present

process of admissions adopted by GGSIPU being the Designated Agency appointed by GNCT of Delhi vide notification dated 05.05.2011 for conducting Common Entrance Test and counseling for admissions in the institutions, affiliated to the said University.

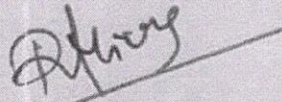
5. The representative from GGSIPU, namely, Ms. Sumita Shiva, Registrar and Brig. P.K. Upmanyu, Incharge (Admissions) also briefed the Committee and apprised that for current academic year 2023-24, GGSIPU has released the Admission Brochure for inviting applications through online mode from the desirous candidates. The seats are filled in different programmes on the basis of the scores of Common Entrance Tests conducted by GGSIPU and the scores/merit of National Level Tests for admissions. It was also informed that the remaining vacant seats shall be filled on the basis of CUET scores/merit.

6. After detailed deliberations, the Committee has decided as follow :

- (i) The Office of the Admission Regulatory Committee will be set up at Indira Gandhi Delhi Technical University for Women, Kashmere Gate, Delhi-110006. The VC, IGDTUW may be requested to provide the office space and other infrastructure including furniture, office equipments and computers with peripherals, etc.
- (ii) For smooth functioning of the ARC, secretarial staff may also be deployed. Accordingly, Secretary (Services) may be requested to post one Section Officer (on diverted capacity) and one Stenographer to be posted from DTTE. The VC, IGDTUW may also be requested to post one Data Entry Operator and One MTS.

7. The meetings of the Admission Regulatory Committee shall be scheduled fortnightly till the completion of Admission process and thereafter a monthly meeting shall be convened.

The meeting ended with Vote of Thanks to the Chair.
