- b) The GGSIPU officers informed that they are charging ₹5000 for management quota forms. The Committee desired to know the legal backing for charging the ₹5000 fee and the details of the authority for deciding various admission fees.

- c) **The Committee directed the GGSIPU officers that in future, Registrar, GGSIPU should attend the ARC meetings. A letter to be written to DHE for suitable replacement of Engineer-in-Chief, PWD as the officer has been retired. Further, the nominated members of the ARC to attend the meetings as per schedule.**
