**PROCEEDINGS OF THE HEARING No. XVII**

A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 18<sup>th</sup> September, 2025 (Thursday) at 04:00 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women Campus, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

At the outset, the Director (TTE/HE) extended a warm welcome to the Chairman and Members present.

- I. **Show Cause Notices issued by GGSIPU:** Initially, the Registrar, GGSIPU, apprised the Committee that Show Cause Notices regarding the challenges faced by aspiring Management Quota students in accessing application forms through the official websites of Maharaja Agrasen Institute of Management Studies, Maharaja Agrasen Institute of Technology and Dr. Akhilesh Das Gupta Institute of Professional Studies were issued. The Notices were as follows: to Director, ADGIPS (No. IPU-7/DI-(Academic)/2025-26/1196 dated 21.08.2025), to Director, MAIMS (No. IPU-7/DI-(Academic)/2025-26/1195 dated 21.08.2025), and to Director, MAITS (No. IPU-7/DI-(Academic)/2025-26/1194 dated 21.08.2025), with directions to submit explanations by 25.08.2025. Now, all the three institutes have submitted their replies to these Show Cause notices.

**ARC's directions: -**

The Committee directed the Registrar, GGSIPU, to conduct a thorough inquiry into the complaints in light of the institutes' replies and to submit a detailed report with findings. Where an institute is found at fault, the report must specify the proposed course of action along with the relevant Statutory Rules which have been flouted and under which Rules such action is recommended by the University being the Affiliating Authority. The findings and proposals are to be presented at the forthcoming ARC meeting.

The Chairman (ARC) further directed the Registrar to provide the following institute wise MQ data: -

1. A detailed break-up of online and offline applications, specifying submission time for each online applications.
2. Admission statistics highlighting:-
  - Number of online applicants who secured admissions.
  - Number of offline applicants who secured admissions.
  - Success rate comparison between online and offline applicants in securing admissions, institute-wise.

## **II. Complaint No. 764, 772 & 774**

Sh. Aman Kumar attended the hearing and presented his grievances regarding non-admission of his son, Sh. Harshil Bhagria in Bhagwan Parshuram Institute of Technology (BPIT) in Management Quota and made the following allegations :-

- BPIT conducted admissions for Management Quota seats in B. Tech. (CET 131) on 09/08/2025 for General Category candidates without announcing or uploading the seat availability for any branch before the counselling. This Second Round of Counselling for the General Category was held in violation of the provisions of DPCI Act, 2007 and the Government instructions.
- His son suffered irreparable loss due to faulty conduct of second counselling by BPIT on 09/08/2025. The University Observer present, failed to prevent Management Quota counselling without prior declaration of available seats for General candidates and notifying general public applicants about second round of counseling for General category. Only vacant reserved category seats were announced. At no point General candidates were informed to participate in the second counselling.
- He attended counselling on 08/08/25, where both the lists released and information provided during the session showed that all seats for CSE and subsequently for other branches were filled. The list published on the night of 8th August confirmed no seats were left vacant in General category for any branch, and no notice regarding a further round of counselling for General category on 09/08/25 was issued.
- Later, upon reviewing the BPIT website, it was discovered that a second round of counselling did take place on 09/08/25. No updated seat matrix regarding vacancies after the 8th August counselling was released, yet seats were allotted on 9th August.
- BPIT conducted a second round of counseling for General category on August 9, 2025, without public intimation to the applicants or mentioning the conversion of vacant reserved category seats into General category.
- BPIT uploaded a blurred list of 13 candidates admitted on August 9, 2025, making it difficult to verify the admission details.
- BPIT allotted reserved category seats to General category candidates without any intimation or justification.

- A candidate with a lower percentage (80.4%) was allotted a seat in Information Technology, despite his son's higher percentage in the qualifying examination.
- The list displayed on August 8, 2025, showed zero seats available for general category candidates, but BPIT conducted a second round of counseling the next day.
- The observers deputed by GGSIP University failed to prevent the unlawful conduct of second counseling.
- The admission process was not transparent, and his son was not given a fair chance to secure a seat in his preferred branch.

**ARC's directions: -**

Considering the serious allegations made by Sh. Aman Kumar regarding the admission of his son at BPIT College, the Committee directed the Registrar, GGSIPU to:

- Stay the ratification process for BPIT students until further orders.
- Conduct a thorough inquiry into the allegations raised by the complainant regarding the admission process.
- Prepare a comprehensive report detailing the findings of the inquiry, clearly specifying the Rules and Regulations flouted by the institute, and outlining the proposed action by the University as the Affiliating Body under the Relevant Rules.
- Submit the Action Taken Report (ATR) before the Committee in the next ARC meeting.

**III.** Thereafter, with the Chair's approval, SO (ARC) presented the Action Taken Report of the University with respect to the proceedings held on 22 August 2025 (received vide Dy. No. 2306/ARC dated 18.09.2025) and a Power Point Presentation outlining group-wise complaints before the Committee Members. After thorough deliberations on the Complaints, the Committee issued the following directives:-

- V. Fee Refund:** -The Committee was apprised about the increasing number of complaints received from students regarding significant delays in the refund of fees by GGSIPU. The Chairman (ARC) expressed displeasure at GGSIPU's failure to comply with the directives issued in the ARC meeting dated August 22, 2025.

In the meeting dated August 22, 2025, Registrar (GGSIPU) was directed to ensure that the process of refund of fees is treated on priority and the refunds should be given strictly in accordance with the UGC guidelines and within 15 days of receipt of request for refund from the student.

Failure on part of GGSIPU amounts to the inappropriate holding up of approximately Rs. 50 crores (approx.) in refund amounts for a period of about two-three months.

The Chairman stated that this inaction is unacceptable and demonstrates a clear disregard for directions of ARC and UGC guidelines in place. The Director (DHE) reiterated this sentiment, emphasizing the financial hardship caused to students who have either secured admission elsewhere or are facing financial constraints.

The Committee directed Registrar (GGSIPU) to immediately process all pending fee refund applications and to ensure that all future refund requests are processed strictly within the 15 day timeline as per UGC guidelines. GGSIPU is to submit reply for non-compliance of the directions of ARC and file a comprehensive compliance report to the ARC before the next meeting of the

Committee, detailing the status of all pending refunds and outlining the steps taken to prevent such delays in the future. The report should include the date of receipt of refund application, number of refunds processed, the total amount disbursed and the new Standard Operating Procedures (SOPs) implemented.

The meeting ended with vote of thanks to the Chair.




