**PROCEEDINGS OF THE HEARING No. XIV**

A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 3<sup>rd</sup> July, 2025 at 04:30 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

At the outset, the newly joined Secretary (HE) extended a warm welcome to the Chairman and all Committee Members. In the beginning, Registrar (GGSIPU) gave the following updates on the ongoing Admission Process for the year 2025-26:-

1. **Admission Progress:** Approximately 15,000 admissions had been successfully completed in the first round.
2. **Smooth Process:** The admission process was proceeding without major issues.
3. **Document Verification:** A significant change this year was the initiation of document verification after the first round of admissions. Previously, verification occurred after all rounds were completed.
4. **Benefits of Early Verification:** By starting document verification earlier, the university ensures that students are confirmed to be in the correct category from the second round onwards. This helps streamline the process and reduces potential discrepancies later on.

Thereafter, with the Chair's approval, a Power Point presentation outlining group-wise complaints was presented before the Committee. The Action Taken Report (ATR) sent by GGSIPU with reference no. IPU-7/Academic/ATRARC/2025-26/828 dated 01.07.2025 received vide diary no. 1621 dated 01.07.2025, was also presented before the Committee Members.

After thorough deliberations on the ATR, the Committee made decisions and issued the following directives:


