**PROCEEDINGS OF THE HEARING No. XIX**

A hearing of Admission Regulatory Committee (ARC) under the Chairmanship of Sh. S.N. Sahai, IAS (Retired) was held on 26<sup>th</sup> November, 2025 (Wednesday) at 05:00 p.m. at Conference Hall, Room No. 216, Admin Block, Indira Gandhi Delhi Technical University for Women Campus, Kashmere Gate, Delhi-110006 to deliberate upon grievances/representations/complaints received from aspiring candidates/parents/other stakeholders.

At the outset, Director (DHE/TTE) welcomed the Chairman and Members of the Committee. Upon commencement of the hearing, Registrar, GGSIPU, apprised the Committee that the Inquiry Committee, constituted by GGSIPU under the Chairmanship of Sh. S.P. Singh, IAS (Retired), has conducted a thorough investigation into various complaints forwarded by ARC regarding alleged irregularities in the Management Quota (MQ) admission process for Academic Session 2025-26. The institutions covered include:

- Maharaja Agrasen Institute of Management Studies (MAIMS)
- Maharaja Agrasen Institute of Technology (MAIT)
- Dr. Akhilesh Das Gupta Institute of Professional Studies (ADGIPS)
- Bhagwan Parshuram Institute of Technology (BPIT)

The Committee has submitted its detailed report, and the same is placed before the Committee.

The ARC Committee reviewed the Inquiry Report and affirmed its core objective: ensuring equal, fair, and transparent Management Quota (MQ) admissions for all eligible students. The complaints highlighted lacks in transparency, underscoring the need for corrective measures. As the affiliating body, GGSIPU must ensure fair MQ processes across Self-Financing Institutes—or initiate strict action. The Committee deliberated on each complaint (institute-wise) vs. the Inquiry Report’s findings/recommendations.

Institute-wise recommendations are as follows:

**(1) BPIT**

The ARC Committee reviewed the major complaint against Bhagwan Parshuram Institute of Technology (BPIT) concerning the non-admission of Harshil Bhagria. Key points from the Inquiry Report:

**Complaint** : Sh. Harshil Bhagria (applied on 8th Aug, in merit) missed admission as on 08<sup>th</sup> August, 2025, zero general seats were shown left by BPIT and he wasn't aware of conversion of reserved category seats to General Category as no clear information was displayed. BPIT converted reserved-category seats to General Category on 9th August 2025 without adequate public notification. A student with lower percentage than Harshil was admitted.

**Inquiry Report recommendations at page 40, point (x) states:**

"BPIT did not create full information symmetry on the conclusion of counseling process on the first day by publishing availability of seats for the General candidates. Moreover, they posted a blurred list of the successful candidates for B. Tech. MQ admissions on the conclusion of second counseling on their website. This is not in consonance with the norms of transparency. A strict warning be issued to BPIT that all the information placed in public domain should be clear, legible and comprehensible."

**Hearing:**

- Complainant Sh. Aman Kumar (Harshil's father) was present, argued lack of transparency.
- BPIT Office Bearers cited Para-8.1.1 (Chapter-8, GGSIPU Admission Brochure 2025-26), claiming the rule was public. Sh. Aman countered he saw zero General seats on 8th Aug., 2025—so no reason to attend counselling on 09<sup>th</sup> August, 2025.

**The ARC Committee feels that:-**

- (a) The merit list stands vitiated as all eligible candidates were not duly informed of the conversion of unfilled reserved seats into General category seats. This failure resulted in a restricted turnout of General category candidates on the second day of counselling, including Harshil, thereby impairing the fairness of the admission process.
- (b) The plea that no violation of merit occurred, cannot be accepted. Once the test of merit itself is rendered defective due to procedural lapses, the question necessarily arises as to why Harshil should be made to suffer the consequences of an unfair and non-transparent process. The counselling procedure lacked fairness and transparency.

- (c) While it may not be possible to retrospectively justify or rectify the entire admission process, the ARC is of the considered view that BPIT ought to make appropriate provision to remedy the injustice caused to Harshil by denying him a fair opportunity to participate in the counselling process for Management Quota (MQ) admissions. The ARC accordingly recommends that BPIT create a supernumerary seat, should Harshil still seek admission.
- (d) During the proceedings, Sh. Aman Kumar (father of Harshil) submitted that he was unable to attend the hearing before the Inquiry Committee constituted by GGSIPU as the intimation email had allegedly been diverted to his “Spam” folder. To verify this claim, the Committee requested him to access his email account and display the said communication from the Spam folder. At this stage, Shri Aman Kumar expressed his inability to do so, stating that he lacked the technical knowledge to operate email accounts. This contradictory stance—first attributing non-attendance to a specific technical cause (the email being in the Spam folder), and thereafter pleading ignorance of basic email operations, renders his submission misleading and casts doubt on his conduct. In view of this, the Committee has directed him to tender an apology for making a false allegation.

**ARC Committee Recommendations for BPIT:**

- a) Sh. Aman Kumar to confirm in writing about Harshil’s willingness to join BPIT in this session 2025-26.
- b) If willing, BPIT must create a supernumerary seat for Harshil with the approval of DHE.
- c) GGSIPU to issue an SoP to all Self Financing Institutes :
- i. Mandate instant updates to all eligible students via SMS/WhatsApp/email/calls etc. for seat conversions to ensure fair chances to all.
  - ii. If de-reservation happens, then the Institutes must (a) Notify cut-off list immediately (b) Club unfilled reserved seats with General giving students enough time to attend counselling.

- d) No financial penalty on BPIT.
- e) GGSIPU to resume BPIT's MQ Admissions ratification process.

**(2) ADGIPS/MAIT/MAIMS:**

The ARC Committee reviewed allegations of admission irregularities at Dr. Akhilesh Das Gupta Institute of Professional Studies (ADGIPS), Maharaja Agrasen Institute of Technology (MAIT), and Maharaja Agrasen Institute of Management Studies (MAIMS).

**Complaint:-**

- Students couldn't fill Management Quota (MQ) online forms due to:
  - Non-functional portals, no offline downloads, no proper acknowledgments
  - ADGIPS-specific: Names missing from merit list.

**GGSSIPU Inquiry Report Findings:**

**MAITS: Para (iii)** - *From the details of submission of application - online/offline mode, submission time etc., it is evident that the online portal was usually functional and the technical issues did not restrict the opportunities for online applicants for any substantial length of time. Out of a total of 819 applications, 783 applications have been received online (i.e. 95.60% of the applications) and the success rate of online applications - 158/176 i.e. 89.77% is overwhelmingly higher than the success rate of offline applications (18/176 i.e. 10.22%). Therefore, there is no reason to believe that there was any erosion in the functionality of the online portal. We may, however, prevail upon MAIT to further technically upgrade their online portal so as to optimize student convenience and ensure an error free system.*

**MAIMS: Para (iv)** - *From the above details, we gather the impression that the complainants' argument about the non-functionality of the online portal of the Institute may be only partially true, as the portal was functional for a significantly larger period and the applicants had a fair opportunity to make applications online. However, we may direct the Institute to work out a significant technical upgradation in the online portal to ensure a more robust online portal.*

**ADGIPS: Para (viii)** - *Having regard to the Acts of Omission and Commission on the part of ADGIPS and keeping in view the interest of the students admitted under MQ in the Academic Session 2025-26, it is recommended that Institute be directed to pay a penalty of Rs. 10,00,000/- (Rupees 10 Lakh) into the Students Welfare Fund of GGSIPU University within a period of one month from the date of approval of the*

report by ARC. The Institute must conduct admission under MQ absolutely in accordance with DPCI rules 2007 and further strict action to be taken against the Institute if any deviation from the same comes to the notice of the University in future. Directions be issued to the Institute under Rule 8(2)(a)(x) of DPCI rule 2007 to comply with the above directions of the Inquiry Committee.

### **Committee Observations & Recommendations:**

**The inquiry report has confirmed that there were technical glitches and portal issues of these Institutes, so following is recommended: -**

- (a) Student interest is priority. Institutes must add portal redundancy—no downtime, no missed admissions, Strengthen portals—handle traffic, smooth submissions.
- (b) DHE to consider submission of MQ applications to GGSIPU also, in addition to individual institutes, to provide additional facility to MQ applicants. Further, DHE to explore possibility of accepting online applications only for the MQ admissions.
- (c) GGSIPU, being affiliating authority to take strict action if similar incidents occur again.
- (d) GGSIPU to take action as per recommendations of Inquiry Committee against these Institutes and submit action taken report (ATR) within a week.

II. Thereafter, with the Chair's approval, SO (ARC) presented the Action Taken Report of the University with respect to the proceedings held on 30 October 2025 (received vide Dy. No. 2454/ARC dated 24.11.2025) and a Power Point Presentation outlining group-wise complaints before the Committee Members. After thorough deliberations on the Complaints, the Committee issued the following directives:-
